

Process

The subcommittee chair solicits scholarship applications through SOFA membership and ODNR service foresters in **February and March** annually.

By **March 1**, the scholarship subcommittee chair has ascertained dates and costs of camp and the amount in the SOFA scholarship fund.

Applications are to be submitted by **April 1st** each year to designated subcommittee member – as noted on the application form.

Prior to the April SOFA meeting, the scholarship subcommittee members individually score each application and confer to arrive at a recommendation regarding scholarship fund award and distribution for the year. The subcommittee may recommend taking funds from the general treasury to cover a shortfall in scholarship recommendation funding.

Subcommittee consistently recommends that any funds not awarded for scholarships are contributed to OFA for scholarships or to meet camp operational costs.

Subcommittee makes recommendations to Executive Committee.

All applications and scoring sheets are retained in SOFA files by the recording Secretary.

Chair presents subcommittee recommendations to Membership for approval vote at regularly scheduled **April meeting**

Designated member of the scholarship subcommittee communicates with each applicant regarding their status **the week after the April SOFA meeting**

Designated subcommittee member follows up with scholars in **July** and plans either a presentation at a regularly scheduled SOFA meeting or a written synopsis of the student's experience at camp.

Scholarship recipients and their families are invited to Annual Meeting and Christmas Party by designated subcommittee member in October of that year.

Assumptions

We want to support relatives and friends of SOFA members in good standing.

We want the camp to remain viable.

We want as many kids as possible to experience the camp.

We want an objective process by which to choose scholarship recipients.

We want to be able to demonstrate that we have used a consistent process in making selections.
